### BPI Contractor Energy Audit & Rebate

The Village of Sherburne Electric Department offers residential electric customers a weatherization rebate. The Weatherization Rebate is leveraging a Green Jobs – Green New York Free/Reduced-Cost Energy Audit program that Sherburne residents are eligible for.

Rebates will cover 50% of the materials cost for weatherization. There is a \$1500 maximum limit per house.

- Audits by a Building Performance Institute (BPI) certified contractor are recommended before weatherization improvements are performed. Audits are usually free!!!
- The BPI certified contractor will direct and assist you in applying for the Free/Reduced Cost Energy Audit.
- The audit report will list the recommended weatherization most beneficial for your home.
- The homeowner then decides (based on their individual budget) what weatherization items to complete from the list.
- The homeowner pays the contractor or if doing the work themselves, buys the materials
- The homeowner then submits a Village of Sherburne Home Weatherization Rebate Form to the Village of Sherburne.
- The rebate amount will be 50% of the materials cost including 50% of spray-foam application, up to \$1500 for the paid invoiced amount of weatherization completed.
- The rebate covers 50% of the insulation (material only not labor), \$50 for each window, and \$100 for doors.
- For windows and doors, include the original NFRC label with the rebate form.
- Don't forget to replace the weather-stripping on your existing doors 50% rebate for that too!!

This program has been approved on an annual basis (Mar.  $1 - \text{Feb.}\ 28$ ) by the Sherburne Village Board of Trustees. You may call the Village Office to verify eligibility.

#### What if I rent?

There is separate rebate program for landlords.

### Are there other rebates or financing available?

Yes. There are financing options available through GJGNY. Contact your BPI certified contractor or NYSERDA directly for financing options and other rebate opportunities.
