## Frequently Asked Questions

## Do I qualify to participate in the Rental Property Program?

All individuals who own rental properties in the Sherburne Electric service territory are eligible to participate in the program.

#### How do I participate in the Program?

Participating is easy. If your total rebate will be under \$1000, all you need to do is submit the rebate form, original purchase receipt and the Energy Guide label or NFRC label. If your total rebate for a project is over \$1000, you will need to contact the Village to receive preapproval for the project.

#### How will I receive the rebate?

Rebates will be sent out in the form of a check. Make sure you communicate your mailing address and not the physical address of the rental unit!!

## Is there a limit on how much I can claim on rebates?

Yes, the limit is \$500 per rental unit, and \$5000 per landlord per year.

What is <u>not</u> included in the rebates? The cost of installation.

Are there programmable thermostats for baseboard heaters? Yes. There are programmables that are wall mounted and there are now programmables that replace the dial-type units right on the heater. Those old dial type are terrible to set, do a poor job of temperature control and end up wasting energy! Your tenants will be more comfortable, spend less on heat with programmable thermostats!!! There is a payback for energy efficient rental properties!!!!


