

Commercial Rebate Program

The Village of Sherburne is offering commercial and industrial customers financial incentives (rebates) for energy efficiency projects. The program's goal is to promote investment in new high quality lighting, motor equipment and electric vehicle infrastructure that operates at a very high level of electrical efficiency.

Do I qualify to participate in the Commercial & Industrial Customers Rebate Program?

Commercial and Industrial customers classified as Service Class 2, 3 and 9 in the Sherburne Electric service territory are eligible to participate in the program.

How do I participate in the Program?

If the total rebate will be under \$2,500, all you need to do is submit the rebate form, original purchase receipt and the Energy Guide label or proof of energy rating. If the rebate is greater than \$2,500, please call ahead. Rebates are limited to \$5,000 per customer, per year.

How will I receive the rebate?

Rebates will be sent out in the form of a check. Make sure you communicate your mailing address and not just the physical address of the facility!!!

Is there a limit on how much I can claim on rebates?

Please call to discuss.

What is not included in the rebates?

The cost of installation.

Heavy Duty Timers (15A min) – Up to \$50 each

Electric Vehicle Charging System (EVSE)

Must be hard wired level 2 or higher.

Intended for employees and/or customers use.

Rebate of 50% up to \$1,500 for single and \$2,000 for dual stations

Heat Pump, ground or air sourced

Must be used for heating and cooling – \$500 per ton

Rebate limit is \$5,000 per year.
