ENERGY STAR qualified products use 10 to 25% less energy than comparable conventional models.

A new ENERGY STAR qualified refrigerator consumes 40% less energy than a 15 year old conventional model. At current *Sherburne* rates, that could save you \$25 per year.

An ENERGY STAR qualified dish washer uses 40% less energy than the minimum federal standard, and one third less water. At current *Sherburne* rates, that could save you \$12 per year.

An ENERGY STAR qualified clothes washer uses 40% less energy and 55% less water than a conventional counterpart. Front load ENERGY STAR washers are the most energy efficient and also prolong the life of your clothes.

Using a programmable thermostat can reduce your heating bill by up to 20%. This is not a sales pitch!! These thermostats keep the home at a more steady temperature and they save you money. A case study performed on a *Sherburne* home showed savings of 10-15% in heating cost with the installation of programmable thermostats controlling base board resistance heat.

Using ENERGY STAR qualified products in only one part of reducing your home's overall energy consumption and ultimately keeping your energy bill as low as possible.

If you want to do your share to help manage the PPA, and you don't already have one, ask to have a *Load Management Hot Water Heater Switch* installed. By allowing *Sherburne Electric's* computer controlled, Load Management System control your electric hot water heater when the Village's electric demand is high, you help everyone by keeping the PPA portion of the bill as low as possible. The switches are installed at no out-of-pocket cost to the home owner.

Frequently Asked Questions**

How do I participate in the Sherburne Electric ENERGY STAR Rebate Program?

Participation is easy. Mail or bring in the receipt from the purchase, the completed rebate form, the ENERGY STAR label that is provided by the retailer or the packaging and for refrigerators, proof of disposal.

How will I receive the rebate?

Upon verification, the rebate will be in the form of a credit on your next electric bill.

What should I do with my old item?

1. Many retailers offer removal when you buy a new unit.
2. You also may take it to a Chenango County Landfill Transfer Station.
3. The Electric Light Department offers a third option of free curbside pickup – for refrigerators only, that have been validated for rebate.

If you're upgrading and updating your appliances, it's time to do the same for your heating thermostats!
